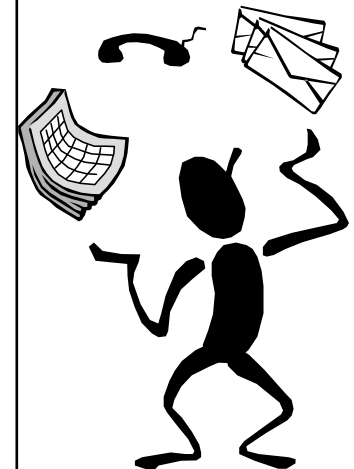

ABOUT INTERIM EXECUTIVE TRAINING

Interim Executive Training is limited to those:

- Who are already in an interim executive/general/associate presbyter or synod position.
- Who are scheduled to begin an interim executive/general/associate presbyter or synod position.
- Who are serving or who have served as an executive/general/associate presbyter or synod executive/associate with references from two other governing body peers.
- Who have been recommended by their governing body as having particular gifts for interim executive/general/associate presbyter or synod work with a recommendation from their Committee on Ministry and their immediate executive/general presbyter or synod executive/associate.



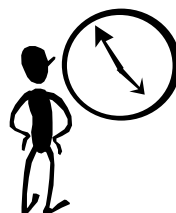
PRE-REQUISITES

Enrollment is strictly limited to 12 persons who have completed at least 30 hours of basic interim training prior to the beginning of interim executive training, and who have registered to complete the entire 60 hours of basic interim training.

TRAINING SCHEDULE

Interim Executive Training is offered in conjunction with MALT Basic Interim Pastor Training each Fall. The event begins at 3:00 p.m. on Friday and ends at 11:30 a.m. on Tuesday. Commuters are welcome with the understanding that they will participate fully in all sessions. Because of the limited registration there will be no cost deductions for commuters.

A \$100.00 deposit is required for each registration. Participants will be accepted in the order in which complete registrations (including COM, governing body, and/or peer recommendations) are received.
