

**NOMINEE RECOMMENDATION FORM FOR
YOUNG ADULT ADVISORY DELEGATE TO THE GENERAL ASSEMBLY**

The 224th General Assembly of the Presbyterian Church (USA) will be held June 20 – 27, 2020 in Baltimore, Maryland. Each Presbytery is invited to send one person as a Young Adult Advisory Delegate at General Assembly's expense. The Young Adult Advisory Delegate will be seated with the Presbytery's minister and elder commissioners on the floor of the Assembly. The YAAD will have the right to vote in an advisory capacity to the General Assembly, will have the right to speak on the floor of the Assembly, and to serve as a full voting member of the General Assembly Committee to which he/she is appointed.

The Young Adult Advisory Delegate must be 17-23 years old on the day General Assembly convenes, and an active member for at least a year of a congregation within the Presbytery. It would be helpful if s/he has had some experience in the Presbyterian Church beyond his/her own congregation, whether in the Presbytery, Synod, or other context. The candidate should have sufficient personal maturity to be able to function independently and responsibly for nine days with other youth and adults and to participate faithfully in the many meetings and activities associated with the General Assembly meeting.
